LOCATION, DESIGN, AND CONSTRUCTION

1. All driveways, adjacent areas, and areas between such driveways including, but not limited to, channelization, paving, and drainage, shall be located, designed and constructed in such a manner as to be consistent and compatible with the design, maintenance, and drainage of the Township Roadway and shall incorporate into the driveway design and mode of construction elements that will accomplish this compatibility. No driveway may interfere with or be inconsistent with the design, maintenance and drainage of the Township Roadway.
2. In order to enable vehicles to turn around before entering the highway, a "loop" or "T" must be constructed to facilitate the vehicle turning around.
